1. Bidders shall bid for all works. Evaluation to be done on collective basis and partial bids shall be summarily rejected.
 2. The contractor should be enlisted under the CPWD or any other Central Government organization to carry out civil works in the state.
 3. The contractor/Agencies should have done at least three central or/and state government/Dept. works and proof /copy of the work order must be enclosed with the tender document.
 4. Warranty of 6 month shall apply for the work. Defects in the warranty period shall be made good by the contractor at no cost to NIT Sikkim.
 5. You must submit the copy of certificate of incorporation, Firm registration certificate, Trade License, GST registration certificate. All these certificates must be in construction trade.
 6. Bidding Agencies may visit the site for any clarification of work and then submit the competitive rate quotation.
 7. Quotation may either be in (a) letter head or (b) as annexure on white page but duly stamped by the authorized signatory along with a forwarding letter on letter head.
 8. The drawing including plans and elevations, for the works should be collected from Estate department at the time of site visit.
 9. Payment shall be made only after the completion of work against the Work Order with satisfactory level. The work must be completed within 75 working days after the issue of the work order.
 10. The quantity of work may differ from the quantity as described in the tender document.
 11. Contract Nos. /Email IDs of Authorized persons of the firm; must be given in the bid envelope and documents along with specimen signatures duly certified by the authorised signatory.

Declaration of the same to be enclosed along with tender document. In suppression of the fact, EMD will be forfeited and the tender will be rejected
14. The work will be strictly executed as per the direction of the officer In Charge of NIT Sikkim.
15. Penalty Clause a) 1% of the bill amount for delay in completion up to 15 days
b) 2% of the bill amount for delay in completion up to 1 month
c) 5% of the bill amount for delay in completion of more than 1 month
16. The EMD of Rs. 30,000/- shall be retained as performance security over the warranty period or the contractor may submit a PBG of equivalent amount for the warranty period.
17. In case of partial or non-execution of work within the stipulated period of work mentioned in the work order, the tender will be summarily rejected provided the amount for the executed work may be released on recommendation of the competent authority and penalty clause will be invoked.
