## **General Terms and Conditions**

- 1. Experienced fabricators, manufacturers, suppliers or dealers of stainless steel furniture may bid for the quoted item. The trade license submitted by the bidder must clearly mention the trade in which the bidder operates.
- 2. All bidding documents and rate quotations must be in English on letter head of bidding firm and duly stamped by the authorized signatory along with a forwarding letter. One signed copy of the tender document, with bidding firm seal, agreeing to the terms & conditions and declaration must also form part of the documents.
- 3. Components must be ISI certified and the components used in the making of the item must be clearly mentioned. A declaration of the brand of components to be used in the fabrication and its certification must be enclosed in the bid documents.
- 4. Bidder should have valid **GST registration** for the financial year 2018-19. Only invoices with serial numbers and printed with **GSTIN** number shall be accepted.
- 5. **Earnest Money Deposit** (EMD) has to be submitted in form of Demand Draft (DD) in favour of "*Director, NIT Sikkim*". **No interest shall be paid on the submitted EMD.** Offer without EMD and tender fee will be rejected summarily except in case of exempted bidders holding valid MSME/NSIC license exempting such bidders from furnishing of EMD. **Submitted EMD** will be returned to unsuccessful bidders.
- 6. Bid or order may be cancelled or delivered furniture may be not be accepted fully or partially at any time if it is found that stainless steel double decker cot differs or deviates from NIT Sikkim's mentioned and accepted specification in the bid. Any action under this clause shall make the EMD/security deposit liable to be forfeited.
- 7. Packing, forwarding, insurance (if any), transportation charges should be inclusive in the price. For any damage/loss during transit, supplier will be solely responsible and damaged/lost furniture must be replaced by supplier at their own cost.
- 8. **Validity:** Bids shall remain valid for 180 days from date of the Tender closing Date.
- 9. **Opening of Bid:** The bids will be securitized by the constituted committee based on requirement suiting to the need of the Institute. Decision of the Institute committee will be final and binding. No query shall be raised on any act or omission of the committee. Any defect in the constitution/quorum/functioning of the committee not affecting the merits of the bid shall not invalidate any decision of the committee.

- 10. All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional tenders shall not be accepted on any ground and shall be rejected straightway. Conditions mentioned in the tender bids submitted by vendors will not be binding on NIT Sikkim
- 11. **F.O.R. NIT Sikkim:** The quoted price must include the transportation up to NIT Sikkim Ravangla campus and successful assembling if any of cots. Any other separate charge (s) will not be paid to vendor. Vendor will be solely responsible for required documents for delivering goods to NIT Sikkim located at Ravangla.
- 12. **Security deposit:** The successful bidder will have to deposit 2% of the order value in form of PBG or may opt to convert the EMD into security deposit for a period of 6 months.
- 13. **Delivery Period:** Delivery period for the cots shall be <u>30 days from date of</u> issue of Purchase order. The institute reserves the right to extend the delivery time on the request with valid reason. Liquidity damage will be levied in case of failure to abide by the delivery period.
- 14. **Responsibility of ensuring quality** with specification lies to the supplier. **The supplying firm must ensure approval of the sample cot by the committee before delivery**. Deviation of technical specification from the approved sample may lead to rejection of delivery or cancellation of order along with forfeiture of EMD. However, in case of minor change in design may be asked by the institute based on the sample and successful bidder is bound to comply with the same.
- 15. **Payment condition:** 100% payment shall be made in Indian Rupees and in favor of bidder through cheque / RTGS after delivery.
- 16. **Liquidity damage**: In case of failure in supply and installation within the specified period or parts of material, liquidity damage shall be charged at the rate of 0.25% of PO value per week.
- 17. If supplier fails to deliver the cots within the delivery period, NIT Sikkim may cancel full order or parts of the order and EMD value may not be returned to the bidder. NIT Sikkim also reserves the right to place the order for the cots to other bidder or supplier in case of failure of the successful bidder. The EMD shall be forfeited in case the supplier withdraws his tender offer during the validity period of the bid.
- 18. **Warranty/Guarantee support**: six months onsite comprehensive warranty from the date of successful delivery should be provided by the bidder. Certificate mentioning acceptance of this clause should be enclosed with the bid.

- 19. **Acceptance of Tender:** The Authority of NIT Sikkim does not bind itself to accept the lowest priced bid and reserves the right to reject any or the entire tender bids received without assigning any reason thereof.
- 20. **Extra Features:** If the bidder provides any other extra features on the material/specification which are not mentioned in the tender product specifications, then that shall be highlighted in clear terms, with documentary evidence/literature.
- 21. Bidder may choose authorized representative with proper authorization letter for attending tender document opening.
- 22. A bid submitted with false information will not only be rejected but also the bidder will be debarred from participation in future tendering process of NIT Sikkim.
- 23. In case of any dispute, the decision of the Institute Authority shall be final and binding on the bidders.
- 24. Credential of supply of similar fabricated furniture to central Govt. / autonomous educational Institute may be attached.
- 25. The authority is not bound to accept the lowest quoted rate if the bidder does not fulfill all requisites as considered necessary in any case the quality of product will not be compromised.
- 26. Any defective material pointed out by authorized representative of the Institution the same shall be taken back by the suppliers for replacement at their own cost.
- 27. The bidder must enclose a valid trade license, GST registration certificate, PAN, or any other certificate evidencing quality, or statutory compliance along with the bid documents duly certified to be true copies.
- 28. **Jurisdiction:** The Courts of Sikkim alone will have the jurisdiction to try and any matter dispute or reference between the parties arising out of this tender. The order shall be interpreted in accordance with the laws of the Union of India.

## **Other Terms & Conditions**


- Arithmetical errors will be rectified on the following basis. If there is discrepancy
  between the unit price and the total price, the total price shall be corrected. If there is
  a discrepancy between words and figures, the amount in words will prevail. If the
  supplier does not accept the correction of errors, its bid will be rejected and its bid
  security may be forfeited.
- 2. NIT Sikkim may waive any minor informality or non-conformity or irregularity in a bid, which does not constitute a material deviation, provided such a waiver, does not prejudice or affect the relative ranking of any bidder.
- 3. The furniture to be supplied under this contract shall conform to the standards mentioned in the technical specifications. And when no applicable standard is mentioned, to the authoritative standard appropriate to the goods' country of origin and such standards shall be the latest issued by the concerned institution / Organization.
- Delivery of the Goods shall be made by the Supplier in accordance with the terms & condition specified in Purchase Order (PO) by NIT Sikkim in the Notification of Award.
- 5. Any subcontract of the placed order will not be entertained and order may be cancelled in summary.
- 6. "Force Majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes. Force Majeure situation arises, the Supplier shall promptly notify Institute in writing of such conditions and the cause thereof for consideration.
- 7. NIT Sikkim reserves right to award the order to one or more bidder.
- 8. Supply of the stainless steel cot shall be to the satisfaction in all terms of NIT Sikkim, else no payment will be made. The decision of competent authority of NIT Sikkim shall be final and binding on firms / Suppliers.
- 9. NIT Sikkim reserves the right to modify in exceptional case any of the stipulated terms and conditions on merit / genuine and justifying grounds if it is in the larger interest of the Institute. The final acceptance of the tenders rests entirely with the NIT Sikkim who does not bind himself to accept the lowest tender. The selection will be made purely on the basis of committee's recommendation, genuineness of the


- firm and based on the technical specification of various products as per printed catalogues & also on the basis of experience, performance, promptness of delivery and requirement of the institute.
- 10. NIT Sikkim official may visit the work place of successful bidder and can review the progress of the work and can instruct the quality.
- 11. NIT may ask for proof of bills or other relevant document for purchase of the material as per desired standard specification i.e. Ply, laminated sheet, square pipes, angles with brands during final payment.


