1. Bidder should have valid GST registration for the financial year 2018-19. Self-attested Copy of the GST registration has to be enclosed with rate quotation.
2. Rate Quotation should be submitted for the desired chemicals in the following format:

3. The bidder should be eligible or in condition to quote the price all chemicals desired quantity as described above. Corrections, if any, shall be made by crossing out, initialling, dating and re writing. All duties, taxes and other levies, transportation charges payable by the contractor under the contract shall be included in the total price **F.O.R. NIT Sikkim**. The rates quoted by the bidder shall remain valid for 60 days. The bid price must be quoted in **Indian Rupees**.
4. Each bidder shall submit only one quotation for each item. Manufacturer/authorized dealers of reputed brands of high technical quality with adequate after-sales support facilities are eligible to apply. It is desired that the bidder has experience in supply of chemicals to reputed educational organization.
5. The bid submitted by the bidder must comprise the following:
  - a) Credentials and list of organisations where the bidder supplied similar items may attach.
  - b) Details of tax and other charges applicable should be clearly mentioned in the quotation.
6. Quotation shall remain valid for 60 days after the deadline date specified for submission.

Notwithstanding the above, the Institute reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract. The bidder whose bid is accepted will be notified of the award of contract by the Institute prior to expiration of the quotation validity period. The terms of the accepted offer shall incorporate in the purchase order.
8. Delivery shall be made at NIT, Sikkim campus, Ravangla, South Sikkim 737139.
9. Payment shall be made within 30 days after satisfactory installation, commissioning and acceptance of the good.
10. In case of failure in supply the chemicals within the specified period liquidity damage shall be charged at the rate 2 % per month.
