#### INSTRUCTION TO BIDDERS

The main object of tender is to enter into a fixed rate contract with the Vendors/Suppliers for supply of the required Electrical material (as per list in the Financial Bid) in the contracted rate.

#### 1. Eligibility & categories for Registration/Empanelment:

All Vendors/Suppliers, which are in the business of manufacturing, stocking or marketing of stores are eligible for applying forrate contract if otherwise suitable, subject to specific conditions or restrictions stipulated in this document.

- 2. Rate Contract Procedure: Procedure for entering into rate contract with the vendors:
  - The applicant should clearly read all the pages of the document. (i)
  - (ii) The vendor must bid for either Group A or Group B or both the group of items as per the financial bid.
  - (iii) Correct/relevant information/data need to be furnished by the vendors.
  - (iv) The applicant should make sure before applying forthe rate contract, that the Vendors/Suppliers has the required eligibility criteria & experience for that work/item.
  - (v) Vendors/Suppliers seeking applications form shall have to pay the requisite fee for Rs.500/- (non-refundable) towards for tender fee. The amount shall be paid by a demand draft drawn in favor of "The Director, NIT Sikkim" payable at Ravangla. The application form shall reach on or before July 15, 2019 at 12:30 PM
  - (vi) The tender documents shall be submitted in two parts.
    - a) Vendor/Supplier shall have to fill and submit the registration form (Annexure -A) along with required documents and DD has to be sent in sealed envelope marked technical bid The Annexure B-D should also should be enclosed with the technical bid.
    - b) The price Bid for the required items should be filled in the given format (Annexure E) and put in a separate envelope and sealed and marked Financial Bid.
    - c) Both the envelopes should be put in a bigger envelope super scribing as "APPLICATION FOR RATE CONTRACT FOR ELECTRICAL **MATERIALS**" clearly on the envelope addressed to:

Registrar National Institute of Technology Sikkim, Barfung Road, Ravangla, South Sikkim, Sikkim-737139.

(vii) Application incomplete in any respect, viz. non-submission of any required document or information, or fee in requisite amount is liable for rejection.

- (viii) The following documents (whichever is applicable) should accompany with the registration form in the technical bid along with one set of signed and stamped tender document:
  - a) GST No. and its certificate with registration type.
  - b) Trade License; Factory License.
  - c) Income tax Permanent Account No. (PAN) (In the name of firm if not a proprietorship firm.)
  - d) Copy of Aadhar Card of proprietor or udyog Aadhar or NSIC/MSME certificate.
  - e) Memorandum and Article of Association, Certificate of Incorporation, Partnership Deed, Registration Certificate issued by the Registrar of Firms etc if applicable.
  - f) Current dealership agreement from Principal of quoted materials.
  - g) ISO certification, if applicable.
  - h) A certificate that the vendor hasn't been black listed by any institution of the Central/State Government or any PSU University; Institute etc. in the past three years should be submitted.
  - i) Institute may ask the vendor/supplier to submit any other certificate from time to time as it may deem fit.
- viii) The Technical Bid will be opened on the date of tender opening and the Financial Bid after evaluation of technical bid. The Financial Bid of only technically qualified bidders shall be opened, as decided by the Technical Evaluation Committee. The decision of the Technical Evaluation Committee (TEC) shall be final and binding on all the bidders.
- (viii) The financial bids shall, be evaluated for the items and the rate contract shall be entered into for each item depending on the price quoted by the vendors.
- (ix) The rate contract for the quoted rate shall be initially valid for a period of 6 months. The rate shall not be changed during the contract period in any case. The rate contract may be further extended by the competent authority as per his discretion.
- The vendor shall provide the required materials for which rate contact has been awarded to him whenever required by the institute at the contracted rates. The order may be placed via a purchase order duly signed by the appropriate authority.
- The brand of the items in the financial bid id final and only the specified brands shall be acceptable to NIT Sikkim. In case of quoting of different brand or delivery of different brand the quote shall be rejected and the delivered goods not accepted.

## **GENERAL TERMS & CONDITIONS**

- 1. NIT Sikkim reserves the rights to accept, consider or reject any or all applications without assigning any reasons thereof. The decision of NIT Sikkim shall be final & binding on all concerned registered firms/vendors in the panel of NIT Sikkim.
- 2. Vendors once contracted, shall have to promptly reply to all the enquiries, execute orders as per the order terms of NIT Sikkim.
- 3. All bidding documents and rate quotations must be in English on letter head of bidding firm and duly stamped by the authorized signatory along with a forwarding letter. One signed copy of the tender document, with bidding firm seal, agreeing to the terms & conditions and declaration must also from part of the documents.
- 4. If any date mentioned above happens to be a holiday, then the next working day will be the relevant date.
- 5. This document is treated as a valid contract between NIT Sikkim and Vendor and adherence to all aspects of fair trade practices in executing the purchase orders/work orders placed by NIT Sikkim from time to time during the registration period.
- 6. In case of contracted vendor is found in breach of any terms & condition(s) of NIT Sikkim or supply/work order, at any stage during the course of supply/installation or warranty period, the legal action as per rules/laws, shall be initiated against the vendor besides debarring and blacklisting the vendor concerned for at least three years for further dealings with NIT Sikkim.
- 7. The vendor should not assign or sublet the rate contract or any part or it to any other vendor in any form. Failure to do so shall result in termination of contract.
- 8. All registered firms are expected to maintain absolute integrity, follow a decent standard of business ethics and do nothing unbecoming of a registered Vendor/Supplier.
- 9. Any subcontract of the placed order will not be entertained and order may be cancelled in summary.
- 10. The NIT Sikkim has all the rights reserved to add/delete/alter any of the items and to mend/add any of the terms and conditions included in the contract granted to firms with effect from any date, without assigning any reason(s) for the same.
- 11. NIT Sikkim reserves the right to accept/reject/all offer(s) without assigning any reason.
- 12. All the terms and conditions mentioned herein must be strictly adhered to by all the vendors. Conditional applications shall not be accepted on any ground and shall be rejected straightway.
- 13. Price Variation Clause: During the validity of the rate contract including the extended period, if the vendor sells any contracted item to any other department / Organization at a price lower than the price offered to NIT Sikkim, the vendor must voluntarily pass on the price difference to NIT Sikkim with immediate effect.

14. Indemnity: The selected vendor shall indemnify the NIT Sikkim and user departments against all third party claims of infringement of patent, trademark/copyright or industrial design rights arising from the use of the supplied items and related services or any part thereof. NIT Sikkim, user department stand indemnified from any claims that the vendor's manpower may opt to have towards the discharge of their duties in the fulfillment of the purchase orders.

#### 15. Termination for Default

- (i) Default is said to have occurred, (a) if the vendor fails to deliver any or all of the services within the time period(s) specified in the purchase order or any extension thereof granted by NIT Sikkim. (b) If the vendor fails to perform any other obligation(s) under the contract.
- (ii) If the vendor, in either of the above circumstances, does not take remedial steps within a period of 15 days after receipt of the default notice from NIT Sikkim (or takes longer period in-spite of what NIT Sikkim may authorize in writing), NIT Sikkim may terminate the rate contract/ Purchase Order in whole or in part.
- 16. Payment Clause: 100% payment will be made within 30 days after delivery and acceptance on submission of valid bills as per the GST rules.
- 17. **Delivery Schedule:** Delivery at NIT Sikkim, order should be executed within the period mentioned in the purchase order. Non availability of stock should be informed in writing immediately. No part supply will be allowed. Defective items or items not as per given brand or sample if any, Vendor/Supplier must take back the items and replace with no additional cost.
- **18 Penalty:** Timely delivery is essence of the contract, hence if any consignment is delayed liquidity damages at the following rate shall be imposed;
  - (a) 1% of the total cost for delay upto 15 days;
  - (b) 2% of the total cost for delay more than 15 days but less than 30 days;
  - (c) 5% of the total cost for delay more than 30 days but less than 60 days;
  - (d) 10% of the total cost for delay more than 60 days;
- 18. "Force Majeure" means an event beyond the control of the Vendor/Supplier and not involving the Vendor/Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine and freight embargoes. Force Majeure situation arises, restrictions Vendor/Supplier shall promptly notify Institute in writing of such conditions and the cause thereof for consideration.
- 19. All disputes in this connection shall be settled in Sikkim, jurisdiction only.
