Notice for Batch 2016 B. Tech students

With reference to letter no: 33-4/2014/TS-III, Dated: 24th June 2016 from MHRD, Govt. of India regarding the waiver of tuition fee to protect the interest of the socially and economically backward students from academic year 2016-17. The National Institute of Technology Sikkim shall charge the tuition fee in the following pattern for different category of students;

1. The SC/ST & PH students shall get full fee exemption.
2. The most economically backward Students (whose family annual income is less than Rs.1.0 lakh) shall get full remission of tuition fee.
3. The economically backward Students (whose family annual income is between Rs.1.0 lakh to Rs. 5.00 Lakh per annum) shall get remission of 2/3rd of the tuition fee.

All the students who comes under full fee remission (whose family annual income is less than one Lakh) and 2/3rd fee remission categories (Whose family annual income is in between 1 lakh to 5 Lakh) **as per list published in the notice during winter 2017 semester only** are requested to submit the joint affidavit (sample attached at Annexure-I) in the stamp paper of Rs. 10 or above along with a copy of latest family income certificate (issued after April 2017) or with a copy of salary certificate of last three month in-case of government employee through post (hard copy) within 12th June 2017 on this address: **Assistant Registrar, Academic Office, NIT Sikkim, Ravangla South Sikkim- 737139** and the scan copy must be send in this email: ar.nitsikkim@gmail.com within 12th June 2017.

After verification, if any changes occur in terms of annual income of socially and economically backward students, the modified fee has to be paid by the students as per their variation in fee remission category and the list shall be published in the website by 20th June 2017. The online payment using SBI Payment gateway will be starts from 3rd July to 17th July 2017.

It is further to inform that, the Annual income certificate has to submit a fresh in every odd semester registration by the students.
