Right to reject any or all tenders, without assigning any reason there of is reserved by the NIT Sikkim.

Instructions to Bidders

The technical and financial bids should be quoted separately and put in different sealed envelopes marked "**Technical bid**" and "**Financial bid**". Those two envelopes are to be put in a separate envelope, which should be properly sealed. The EMD and Tender fee should be enclosed in the **technical bid** in the form of A/C payee DD in favours of "**Director**, **NIT Sikkim**" payble at Ravangla, South Sikkim.

- 1. The financial bid should include the cost of main equipment/items and its accessories. If there is any separate cost for **installation**, **warranty extension** etc. that should be quoted separately.
- 2. The quotations shall be submitted in a sealed envelope duly marked "Tender reference no., Dated" and "Closing date of submission:" on the corner of the envelope.
- 3. The printed literature and catalogue/brochure giving full technical details should be included with the technical bid to verify the specifications quoted in the tender. The bidders should submit copies of suitable documents in support of their reputation, credentials and past performance. The rates should be quoted in figures (typed or printed) and cutting should be avoided. The final amount should be in figures as well as in words. If there are overwriting, they should be duly initialed, failing which the bids are liable to be rejected. No alternate price will be entertained in the quotation.
- 4. All tender documents should have to be sent through courier, speed post or registered post only or may be dropped in person at NIT Sikkim. Quotation received after the closing date/time will not be considered.
- 5. While sending rates, the firm shall give an undertaking to the effect that "the terms/conditions mentioned in the inquiry letter/Tender Notice against which the rates are being given are acceptable to the firm." In case the firms do not give this undertaking, their rates will not be considered.
- 6. The supplier/firm must be either original equipment manufacturer (OEM) or authorized dealer/sole distributor of quoted items, the certificate to this effect must be attached.
- 7. The quantity shown against the item is tentative and may vary as per dynamic requirement of the Institute.
- 8. In the event of any dispute or difference(s) between the vender Institute (NIT Sikkim) and the vendor(s) arising out of non-supply of material or supplies not found according to specifications or any other cause whatsoever relating to the supply or purchase order before or after the supply has been executed, shall be referred to "The Director, NIT Sikkim", Sikkim who may decide the matter himself.
- 9. All tenders in which any of the prescribed conditions is not fulfilled or any condition is put forth by the tenderer may be summarily rejected.
- 10. Successful bidder have to deposit PBG of 10% with validity up to the product warranty period after the P.O. is endorsed to the suppliers. If not received, 10% will be deducted from invoice and balance will be paid to the supplier.

In exceptional situation, an authorized committee may negotiate price with the qualified bidder quoting the lowest price before awarding the contract.

General Terms and Conditions:

Clarifications:

In case the bidder requires any clarification regarding the specification/tender document, they are requested to contact Dr. Anjan Kumar Ray (e-mail: <u>akray.nits@gmail.com</u>), HoD In-charge of EEE or Mr. Molay Roy (**molay.roy@gmail.com**), Assistant Professor, NIT Sikkim on or before 16/11/2016.

Pre – Qualification Criteria:

- 1. Bidder should be the manufacturer/authorized dealer. Letter of Authorization from original equipment manufacturer (OEM) on the same and specific to the tender should be enclosed for items as required.
- 2. ISO certified company shall be preferred.
- 3. The bidder must be a registered/authorized firm with TAN/VAT/CST/PAN registration clearly mentioning the scope of items authorized to supply from the registration authority. Suitable documents should be enclosed.
- 4. The bidder must have experience in similar supply to central universities, IITs, NITs in the past. Suitable documents should be enclosed.
- 5. For **Equipment Set B**, the bidder must have supplied similar items to central universities, IITs, NITs in the past. Suitable documents should be enclosed.
- 6. The Bidders may quote for Equipment Set A and/or Equipment Set B for consideration.

Prices:

The Prices quoted should be inclusive of all taxes or duties, packing, forwarding, freight, insurance, delivery and commissioning etc. at destination site (NIT Sikkim, Ravangla, Sikkim). The rates shall be firm and final and nothing extra shall be paid on any account without further approval of the competent authority. The bidder should add 1% as ECESS on total value payable to the Govt. of Sikkim.

ECESS @1% of the cost of total value to be paid to Sikkim Govt. and the cost for road permit must be borne by the suppliers. This is the cost of special permit for nationally important educational institution like NIT Sikkim. The NIT Sikkim may help in arranging waybill against invoice. However, the charges @1% + cost of procurement (Form cost etc.) shall be deducted from the total bill amount and balanced will paid to supplier bidder. If way bill need to be arranged by NIT Sikkim, then bidder must produce invoice 2 weeks before delivery.

Validity:

The bid should be valid for acceptance for a period of 90 Days. The bidders should be ready to extend the validity, if required.

Delivery:

The Equipment should be delivered and installed within the period as specified in the purchase order and be ready for use within 8 weeks of the issue of purchase order unless otherwise prescribed.

Liquidated Damage:

If the bidder fails to deliver and place all the Equipment or perform the service by the specified date, penalty at the rate of 1% per Month of the total order value subject to the maximum of 10% of total order value will be deducted.

Warranty

Bidders must give the comprehensive onsite warranty for at least one year from the date of successful installation of Equipment against any manufacturing defects and also give the warranty declaration that "everything to be supplied by us hereunder shall be free from all defects and faults in material, workmanship and shall be of the highest quality and material of the type ordered, shall be in full conformity with the specification and shall be complete enough to carry out the experiments, as specified in the tender document."

Any deviation in the material, and the specifications from the accepted terms may liable to be rejected and the bidders need to supply all the goods in the specified form to the satisfaction/specifications specified in the order/contract and demonstrate at the their own cost.

Vender selection:
