This is to notify that for all the pursuing students of B.Tech, M.Tech, Msc, & PhD programme, the registration dates and basic guidelines for winter semester 2017-2018 are as follows:

1. Online payment **only** accepted through payment gateway using credit/debit card/other online instrument starting from 26th Dec 2017 – 22nd Jan 2018 (without late fine). Other modes of payment such as demand draft, banker's cheque are strongly discouraged.
2. Physical registration at institute from 18th, 19th and 22nd Jan 2018.
3. Class commences from 22nd Jan 2018.
4. If any student fails to make their payment and physical registration on the above dates, they will **only** be considered for late registration as mentioned below:
 - a. Registration with late fine of ₹1000/- along with supporting documents* from 23rd to 27th Jan 2018.
 - b. Registration with late fine of ₹1000/- plus additional ₹500/- per day, with supporting documents* from 29th Jan to 9th Feb 2018.

**Note: Supporting documents are:*

- I. *Medical Certificate of the student from a registered medical practitioner for a leave of less than 5 days. And a medical certificate from the Chief Medical Officer/ Medical Superintendent for the leave of more than 5 days, or*
 - II. *In case of genuine calamity in the family, or*
 - III. *Students under Industrial internships/short term courses duly authorized by the Institute on the recommendation of HoD's or Faculty In-charge, T&P Cell, or*
 - IV. *Any other special case with the approval of the competent authority*
5. The registration process will be closed on 9th Feb 2018 and no registration shall be considered for the winter semester 2017-18.
 6. Bank account details for the payment of institute and hostel fee of NIT Sikkim is as mentioned below. Deposits in other accounts/excess amount, if any shall not be entertained.
