
ON RELIEF ASSISTANCE TO TEESTA FLOOD-HIT PEOPLE STAYING AT RELIEF CENTRE IN SIKKIM

SIKKIM FLASH FLOOD

The cloudburst, coupled with the melting of the Lhonak Glacier, which resulted in the Glacier Lake Outburst Flood (GLOF) caused sudden release of massive amount of water from the Lhonak Lake located in the Northern parts of Sikkim at an altitude of 17,100 feet.

In the wee hours of 4th October 2023 when the entire people of Sikkim were sound asleep, a sudden surge of water flow due to outburst of Lhonak Lake took place following the devastating flash flood severely affecting North and Eastern parts of low lying belt in Sikkim The River Teesta took a furious form claiming several lives, causing widespread damage to roads, personal properties, communication systems and washing away several bridges.





The Sikkim Government has declared this catastrophe as 'DISASTER' as per the Disaster Management Act, 2005.

NOTIFICATION

Cloud burst induced water surge around Lhonak area led to flash floods in low lying areas of Teesta basin causing rise of water levels with very high velocities downstream within the States of Sikkim and West Bengal in the early hours of 4th October 2023. This has caused extensive damages to life and property including breakdown of road networks and communications. Several important brigdes connecting to the forward border areas and withn sikkim are washed away due to the above flash floods in Mangan, Gangtok, Pakyong and Namchi Districts of Sikkim.

Hence, with the approval of the Chairman, Sikkim State Disaster Management Authority and as recommended by the State Executive Committee (SEC), I, Vijay Bhushan Pathak, IAS, in the capacity of Chairman, SEC hereby declare this catastrophe as a Disaster in exercise of the powers conferred vide Section 22(2) (b) of the Disaster Management Act, 2005, (53 of 2005)

The rescue operations and evacuation commenced as soon as the flood hit the state. The state government has set up several relief camps for the victims who have faced most of the damages. There were many people who voluntarily came forward with the intent of helping the people affected.







The Community Development Cell of NIT Sikkim has organized a voluntary donation drive in the college premises to contribute to all those who were affected by the flood. It was a one-day drive keeping in mind to reach out to the affected people promptly and expeditiously. We chose the accessible relief camp Namphing, Shri Krishna Pranami Mandir where around 600 disasters displaced people were in housed.









The faculty, staff members and students have donated reusable clothes, dry food items and monetary aid. The drive was initiated immediately so that the relief materials and needful assistance may

monetary aid collected, we bought basic necessities like food items, other essential commodities and clothes were donated in huge quantities.

A whopping number of people came forward to lend a helping hand in such a misfortunate time like this. The concerned team coordinated to transport these items and it reached the victims on the very next day. Not only this but the team also initiated to prepare lunch for them on the same day offering a familiar taste of home cooked food during such a difficult time.















Later, cleanliness drive was also carried out in order to help the disaster displaced people maintain proper hygiene and cleanliness in the surrounding areas. This situation demonstrates people's capacity to help other people as well as themselves.



It was indeed abliss to see everyone come together as one community during the need of the hour and the drive concluded with an absolute satisfaction and a sense of fulfillments in our hearts.
