[#] While discussing this item, the Financial Adviser, IFD, MHRD, pointed out that NIT-Sikkim could avail the benefit of expertise of sister institutes, as well as consultation with MHRD, to ensure the required compliance in format, classification etc. in submission of the details of accounts.

Director's report

The Director further reported on academic programmes, ICT, R&D, land status, training & placement etc. The Board acknowledged the problem of space and at the same time appreciated that more than 80% students have been placed in the first batch in spite of the constraints.

Item No. 4.03: Procurement of a bus for the students and other utility.

Members from MHRD mentioned that a request letter may be sent to the MHRD mentioning the reasons so that it can be taken up with the Finance Ministry for approval. In the meantime, the Institute may use hired bus services.

Item No. 4.04: To consider recruitment rule and procedure etc. for faculty recruitment

The proposed Recruitment Rules based on MHRD Letter No. F.33-2/2012 – TS.III dated 5th February 2014, along with a provision for considering candidates pursuing PhD at distinguished institutes on contractual appointment, were approved.

Item No. 4.05: To consider rule for Non-Faculty staff Recruitment Rule

The Recruitment Rules as per the MHRD Letter No. F.33-2/2012 – TS.III dated 5th February 2014 were adopted.

Item No. 4.06: Non-availability of land and associated problems

The Principal Secretary, HRDD, Government of Sikkim informed that the process of acquisition of land at Khamdong is in progress.

It was opined that a letter from the Chairman, BOG may be sent to the Government of Sikkim expressing its concern over the land issue. In the meantime, to quicken the construction as soon as the land is handed over the Director was authorized to hire accommodation around Singtam / Khamdong as required for preparation beforehand. Considering the gravity of the land allotment situation, the Principal Secretary, HRDD, Sikkim agreed to show the tentative map of the earmarked land, which may help in making arrangement for hiring Architect for preliminary survey etc.

Item No. 4.07: To consider Budget for 2014-2015

The budget was approved as proposed. Further expenditure planning should be linked to the flow of funds from the Ministry. In this connection, MHRD representative enquired about the delegation of financial power in the Institute. The Director mentioned that as per the NIT Statutes, director may incure expenditure within the budget provisions. However, for delegation of power including for the deans, heads of the departments etc., it was suggested that the Director may furnish specific information in this matter collecting data from some other NITs. It was also suggested that the Registrar, NIT, Allahabad may be contacted for early reference.

Item No. 4.08: AoB with permission from the Chair

The Director informed about the DST sponsored INSPIRE Summer Internship Programme scheduled to be held at NIT Sikkim during 23-27th July 2014, and cordially invited the BOG Members to the event.
