## MEMORANDUM OF UNDERSTANDING (MoU) BY AND BETWEEN NATIONAL INSTITUTE OF TECHNOLOGY

#### Ghoshpur, Champahati, South 24 Parganas, West Bengal-743330

This Memorandum of Understanding (MoU) is made on 23 Nov, 2024, 2024 between NATIONAL INSTITUTE OF TECHNOLOGY, Sikkim and SUSHIL KAR COLLEGE, West Bengal, for mutual cooperation in academic exchanges, program development and research. This document establishes the guiding terms and principles of collaboration between the two organizations:

#### I. LEGAL FRAMEWORKS OF BOTH THE ORGANIZATIONS

National Institute of Technology Sikkim is an Institute of National Importance, functioning under the aegis of Ministry of Education, Government of India. NIT Sikkim is one among the ten newly sanctioned National Institutes of Technology set up by the Government of India under the 11th Five year Plan, 2009. NIT Sikkim started functioning in August, 2010. The Institute is represented by its Dean Academic, Dr. Ranjan Basak, hereinafter referred to as the FIRST PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns).

Sushil Kar College is a West Bengal government aided co-educational under graduate College with Arts, Science and Commerce streams under the University of Calcutta. The college was established in the year 1968 and is NAAC accreditated with Grade 'B', third cycle in 2023. The college is represented by its Principal, Dr. Manas Kumar Adhikari, hereinafter referred to as the SECOND PARTY (which term or expression shall unless excluded by or repugnant to the context be deemed to mean and include its successor in office, representatives, administrators, and assigns). Both these organizations will be hereafter referred to as Parties.

## **II. PURPOSE OF THE AGREEMENT**

Both the Parties are pleased to enter upon an agreement to establish ties of academic cooperation in order to contribute to the achievement of their overall goals as institutions through the following proposed activities:

- 1. Joint teaching and research projects.
- 2. Collaboration in the area of academic and research activities.
- 3. Academic visits of students, training and exchange of faculty, sharing of library resources.
- 4. Joint educational initiatives.
- 5. Joint consultancy, Ph.D. supervision, scientific publications.
- 6. Co-hosting and participation in conferences, seminars, symposiums and workshops.
- 7. Social and cultural programs.
- 8. Organizing Yoga, Physical activity and Mental stress relief Camps by the direct Guidance of Sushil Kar College NCC Unit (under 20 Bengal Bn NCC, WB & Sikkim DTE) under the supervision of ANO, Sushil Kar College.
- 9. Any other activity that is mutually agreed upon and is beneficial to both.

#### **III. EXECUTION OF THE AGREEMENT**

The specific activities to be carried out under this agreement will be stated in corresponding specific sub-agreements. Such specific subagreements, once approved by both parties, will be attached as annexes to this agreement.

The specific sub-agreements between both Parties will specify their objectives, conditions and ways of execution, financial support, period the sub-agreement will be in effect, and administrative responsibility within each institution.

#### **IV. TERM AND EXPIRATION OF THE AGREEMENT**

It is understood that this agreement will come into effect after being signed by both Parties and will be established for a period of three years. After three years, it will be automatically extended for the same period, unless one of the Parties expresses an intention (by written notification) to cancel the agreement at least 90 days before the expiry date. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the Parties.

Any additions, changes, or deletions to this document must be approved by the representatives of both the Parties. All notices shall be in writing and shall be directed to these representatives.

#### **v. NON-EXCLUSIVITY:**

This Agreement is a non-exclusive agreement, and both parties remain free to enter into similar agreements with third parties.

#### **VI. SPECIAL PROVISIONS**

- 10. Each party will take approval from the other party in writing prior to using the latter's name and logo for the activities hereunder on a case-by-case basis.
- 11. All parties hereto shall do their utmost to ensure the smooth and efficient implementation of the programs.
- 12. Neither party will have any financial obligations.

#### **VII. DISPUTES**
