Refund Rules for UG, PG & Ph.D. Program

That, the refund policy/rules of the respective admission board/ authority viz; JoSAA/ CSAB/ CCMT/ CCMN/ DASA etc. will be final and will **NOT supersede** by this Institute Rules.

That, in absence of the clear refund policy/rules from the above admission board/ authority, this refund rules shall be applicable as per the Institute Norms.

That, this refund rules will be applicable from the academic year 2023-24 for undergraduate (UG), postgraduate (PG), and Ph.D. programs.

<u>Category- A</u>: Refund rules applicable for withdrawal from the UG & PG program where the seat is allocated by the admission board/ authority viz; JoSAA/CSAB/CCMT/CCMN/DASA etc:

Candidates not reporting to NIT Sikkim till the last date of admission after seat allotment by the seat allocation board.	Upon the transfer of funds to NIT Sikkim by the seat allocation board, a deduction of Rs. 10000/- will be made from the total fee paid to the seat allocation board (JoSAA/CSAB/CCMT/CCMN/DASA) and the balance amount will be refunded to the candidate on request. - 1. The refund will be initiated after the completion of admission process and after transfer of the fee from the respective admission board viz; JoSAA/CSAB/CCMT/CCMN/DASA to the Institute.
- 2. Institute will follow the refund rules for fees as per the MoE guidelines notified from time to time.
- 3. In case of natural/ accidental death or major causalities of the students which restrict her/his continuity in the studies, in such case tuition fee+ Hostel/Mess fee of that semester and caution deposit will be refunded.
