PREAMBLE

The premises of NITs, with thousands of students from diverse backgrounds, are similar to a country in small scale. The Institute is a family of students, staff and faculty members that must draw a steadiness between the freedom to showcase the intellectual activities and a respect for the rights of all members to enjoy such freedom to the same extent. Students must have fair perceptions of their rights and responsibilities, Dos and Don'ts. Acts of indiscipline affects the reputation of the Institute and it must be avoided to ensure the sustainable development in a holistic environment.

The responsibility of maintaining discipline in the institute is largely on the shoulder of the institute's administration where the assistance of the Senate, members of the faculty and the student community is essential. This manual aims to simplify the procedure of implementation the discipline and to frame the related administrative actions. It is important to ensure the action through collective decision making in fair means to deliver the justice. The decision making committee is consisting of faculty and students, however the supreme authority rests with the Senate and its Chairperson.

It is highly expected that the students of NIT Sikkim will abide the proper code of conduct and therefore the Discipline Manual will have nominal uses.

CODE OF CONDUCT

The following code of conduct signifies the borderline between acceptable and nonacceptable conduct of students and it is strongly believed that the students will abide by the code of conduct.

- 1. The students shall conduct in a manner befitting their association with the statutes of NIT Sikkim as an Institute of National Importance. The students shall be cooperative with human values and moral ethics while being innovative and pursuing excellence in academics. Students shall not indulge in any activity that affects the honor and reputation of the Institute.
- 2. Students shall give due respect and courtesy to the faculty and staff members, fellow students and visitors. Students shall exhibit proper decorum and behavior both inside and outside the premises.
- 3. Students shall not indulge in any activities that can be considered as **Ragging**. The Annexure-I can be referred to understand the acts that constitutes Ragging.
- 4. Students should respect the rights and dignity of fellow students, employees and visitors of the Institution and they should maintain the holistic environment which is free from all forms of harassment and discrimination such as regional, lingual, complexion, gender, caste, race, religion, physical and mental disability of an individual, etc.
- 5. Students must exhibit highest honesty and integrity both inside and outside the campus. They should not furnish false statement and fraud document in any kind. Students should be honest and focused in academic studies. They shall refrain from academic violations of any kind such as plagiarism, copying, cheating, adoption of unfair means in the examination, etc.
- 6. Students' health, safety and security is utmost important. The students must not be involved in any activities such as smoking, consumption of alcohol, tobacco, drugs, any kind of harmful substance, etc. that could harm their health and academic performances/behavior.
- 7. No student should involve in promotion, production, sell and distribution of any such intoxicating substances inside and outside the campus. Further, no student is allowed to sell or distribute any item without permission.
- 8. Students should not involve in any type of verbal and physical abuses/scuffles/fights inside and outside the campus irrespective of any cause.
- 9. Students must not indulge in any indecent act that results stealing, damaging, defacing, misusing any public, private and Institute property. Also, the students should not make

personal use of any property of the Institute without prior and proper approval from the authority.

- 10. Students in general should not produce/fabricate/manipulate/circulate any information, allegation, baseless charges, propaganda and manipulated evidences, etc. against any individual and Office/Department/Institute, which could affect/harm the Department/Institute/Society/Nation.
- 11. Students must not involve in any activity that hampers teaching, research, administration, co- and extra-curricular activities and regular functionalities of the Institute.
- 12. Students must not attend gathering and processions without prior approval from the Department/Institute.
- 13. Possession or use of weapons, explosives and destructive items which are against the security and safety norms are strictly prohibited both inside and outside the Institute premises.
- 14. Student(s) must not engage in any kind of harassment activities such as physical, mental, social and sexual.
- 15. Student(s) must not use mobile phone or any electronic gadgets inside the classroom (both theory and laboratory). They must not involve in the activities like audio-video recording, capturing pictures, and streaming audio or video of any individual, classes, laboratories, workshop, meeting, social gathering, private zones unless have permission from the authority for the same.
- 16. Students should not invite media inside the Institute premises without prior approval of the competent authority. They must not circulate any information, photographs, audio/video clips of any activity to any kind of media such as print, electronic and social without prior approval of the competent authority of the Institute. Because this may damage the reputation of the Institute. They should not communicate with any media person on behalf of the Department/Institute or any individual without prior approval of the competent authority.
- 17. Student(s) should take all precautions and security measures for their health and safety. They should strictly adhere to the preventive measures, safety and security instructions inside and outside the campus including laboratory classes, workshops, sports and games activities, gymnasium, etc.
- 18. Student(s) should follow all traffic rules and driving instructions inside and outside the campus. They should park their vehicles in appropriate designated locations only.

- 19. Student(s) should always carry their Institute identity card inside the campus and produce it for verification whenever asked by any Faculty, Staff and security person.
- 20. As a responsible citizen of the nation, it is imperative for each student to preserve and protect the environment; keep the surrounding neat and clean; protect and plant trees; avoid use of plastic; keep their academic and other facilities clean and maintained. Students should also maintain their personal hygiene and cleanliness.
- 21. Student(s) must abide by the law of the Institute/state/country. They must exhibit their responsibility as a law-abiding citizen. They should not be associated to any activity, group and organization that are banned by the Institute or Central/ State Government or are damaging to the image of Institute/State/Nation.
- 22. Student(s) shall not, through act or omission, assist another student, individual, or group in committing or attempting to commit a violation of this code of conduct. Any student who has knowledge of another committing or attempting to commit an act which is in violation of the code of conduct must report the same to the respective authority of the Institute and must keep herself/himself away from that situation/activity. Intentional failure of reporting such incidents will lead to punishment.

CONDUCT RULES FOR RESIDENTS OF HOSTELS

In general, the NITs are fully residential institutes. However, if enough hostel accommodation is not available, the NIT Sikkim is not responsible to arrange or provide the boarding facility to each and every student. The hostel facility provided to a student stands withdraw if s/he fails to comply with the rules and regulations of the Institute. Institute provides separate hostel facility for boys and girls and may have similar or different conduct rules. In addition to the general code of conduct, the hostel residents have to follow the following rules and regulations failing which they are liable to disciplinary action as stated in this manual or otherwise:

- 1. Institute accommodation is not a right but a privilege offered to the student. Institute may withdraw the facility at any time with prior notice as per the need.
- 2. The objective of the NITs is to have national integration through interaction of diverse students in terms of native, language and social background and to fulfill this, the allotment of the hostel rooms shall be made by the Dean Student Welfare accordingly.
- 3. The allotment and allotment procedure of the rooms in the hostels shall be made by the committee constituted for this purpose and the decision of the committee shall be binding on all the students. The Dean Student Welfare shall be the convener of the committee.
- 4. Student(s) are not entitled to share/exchange/give their assigned hostel accommodation to any other student.
- 5. Student(s) are strictly prohibited to allow any outsider to enter or stay in the hostel without written permission of respective hostel warden.
- 6. Student(s) are not entitled to modify/refurbish/renovate their assigned room or hostel without written permission of the respective hostel warden.
- 7. Family accommodation may be available only to the married PG students if available. However it shall not be provided if the married student stay without family members. Periodical visit of family members may not be considered for family accommodation.
- 8. Student(s) should make their rooms available whenever required for inspection, repair and maintenance, disinfecting/cleaning.
- 9. Student(s) have to vacate the rooms while leaving for the semester vacations as per the direction of the warden/ chief warden/ DSW.

- 10. Students are required to use the room, furniture, electrical items, etc. properly. Noncompliance of these shall invite heavy penalty.
- 11. The common facilities in the hostels, and out-side the hostels are the responsibility of the students and therefore, have to utilize judiciously with care.
- 12. Student(s) shall be responsible for the safe keeping of their own belongings and Institute's property. The Institute shall not be responsible and liable to compensate for any loss, stealth and damage of any personal belonging of the student. However, damage to Institute property shall invite disciplinary actions.
- 13. Engaging personal attendants, keeping pets and use of prohibited appliances like heater, cooking appliances, refrigerator, electric iron, etc. inside the hostels are strictly not allowed.
- 14. Student(s) have to strictly follow the timing of the hostels for their in and out movement.
- 15. Student(s) must not enter other hostels without prior approval of the respective hostel warden.
- 16. Entering hostels of opposite gender is strictly prohibited.
- 17. Entry to the hostels of junior students is not permitted in general. However, in exigencies the senior student(s) may enter the hostel with prior written permission of the respective warden/chief warden.
- 18. Non-boarders including day scholars should not stay in the hostel without prior written permission of the respective warden/ chief warden.
- 19. Student(s) are required to actively participate in different hostel management committees and other welfare activities for proper management, etc.
- 20. Students' mess activities shall be limited to the allotted space only. The mess shall function as single integrated unit without any division in any groups or subgroups, and shall be managed by the students' committee for this purpose under the convenership of the warden/chief warden.
- 21. Student(s) are not allowed to cook anywhere in the hostel/Institute without specific written permission of the warden/ chief warden/ DSW.
- 22. Students must park their vehicles in the specified/allotted parking area.
- 23. Arranging any kinds of Party/celebration inside hostel is not permitted.

4. Two faculty members nominated by DSW, of which one shall be women and other from SC/ST/OBC —Member

All minor acts of indiscipline, misconduct, misbehavior and any other at departmental level shall be taken care of by the HOD or Departmental disciplinary committee. The student may appeal against the penalty/ disciplinary action taken by the committee for review/ reconsideration to DSW/ Dean Academic/ HOD as the case may be. However, the decision of the committee/ Dean shall be final and binding to all.

DISCIPLINARY PROCESS

The following steps shall be followed in case of any misconduct or act of indiscipline in the Institute.

Step 1: Early Resolution and Reporting

The act of indiscipline/misconduct can be reported by the aggrieved student/guest/visitor/faculty/staff/officer of the Institute, witness(s) of the act, etc. to the office of the HOD/Dean/Registrar/Director. The complaint so received by any of the office shall be forwarded to the concerned Dean/HOD for necessary action and resolution.

It is expected from HOD/ Dean/ Registrar/ faculty member/staff/officer of the Institute to resolve the complaint amicably with the intimation to the concerned HOD/Dean. If the complaint/issue is not resolved in time the same shall be forwarded to the concerned HOD/ Dean and the concerned HOD/Dean must take prompt action and may forward the same to the concerned disciplinary committee in timely manner. The committee on receipt of the complaint has to act promptly and resolve the issue within seven (07) days. The committee is free to take any disciplinary action against concerned and may impose penalty as deemed fit. The penalty may be financial, academic, etc.

Step 2: Investigation

The committee members shall meet after receiving the complaint/ report of misconduct act. The responsibility lies with the committee to conduct the proceedings, hearing, interaction and investigation as required considering the gravity of the act. The student(s) must appear before the committee if asked to do so. If any student fails to appear consecutively two times without any logical reason, the committee must take action and appropriate decision.

Step 3: Decision

The committee must take the necessary decision and send its recommendation to the concerned Dean. The Dean may issue the notification by accepting the recommendations or may seek the approval/ directions of the Director if necessary. The Director may approve the recommendations or may reduce the level of penalty/punishment. The Director may suggest for the review or place before the SUGB/ SPGB/ Senate. The final decision shall be notified by the office of the concerned Dean.

Step 4: Appeal

Aggrieved student(s) has the right to appeal to review the penalty/ punishment to DSW/ Dean Academic within seven (07) days of the notification of the same. The concerned Dean may accept or deny the appeal based on the facts submitted by the student. If deemed necessary, the Dean may place the appeal before the committee for final decision and can take action as per the step 3 mentioned above.

MISCONDUCTS, SUGGESTED CORRECTIVE MEASURES, PENALTY AND PUNISHMENT

The types of misconduct and suggested deterrents/ corrective measures are tabulated as basic guidelines to the concerned Institute authority/ committee to provide uniformity in decisions against the act of indiscipline. However, the authority/committee is free to impose penalties, punishment and corrective measures beyond the measures tabulated below. Any offence/ act of indiscipline which is not included in the list shall be handled by the authority/committee appropriately.

1. Academic Misconduct

1	Proxy in attendance/signing for another student/ Leaving the class after giving	FA grade shall be awarded to the student who is caught signing for another student in a course. If a student is found giving proxy in attendance/
	attendance	missing at the end of the class after having given attendance, a warning shall be issued by the Instructor. If a second violation is detected, the penalty shall be deduction of one grade. Further, repeated offence will lead to FP grade in the concerned subject along with disciplinary action.
2	Impersonation of a student during exams.	The disciplinary action taken against both the involved students shall be suspension for one or more semesters.
3	Tampering with Academic Documents like Grade Sheets, Degree Certificates, etc.	Termination from the Institute if degree not awarded or withdrawal of the degree if already awarded. The decision shall be taken by the Committee/Senate/BoG accordingly.
4	Tampering with official documents like medical certificates, Income Certificate etc. In case of tampering of Medical Certificate awarded to the student of the course.	
		For other certificates, the decision shall be taken by the Committee constituted under the Chairmanship of Dean Student Welfare/Dean Academics and the decision of the Committee shall be binding on the concerned student(s).
5	Forging signatures of faculty/staff or any other	The disciplinary action against the student(s) - suspension for one or more semesters/termination from the program and expulsion from the Institute.

6	Copying in home assignments, programming assignments and laboratory projects	A student, found copying in assignments/laboratory work/project, will be given zero mark respectively and one grade penalty. The same disciplinary action shall be taken against the student copying and the student from whom the material has been copied. If it is found that the student who copied/ obtained the material through nefarious means like hacking etc., the student from whom the material was copied may not be punished.
7	Communicating with other students during examination	If a student is found verbally communicating with another student during the examination, in the absence of any other evidence except a signed note from the invigilator, the penalty shall be loss of one grade.
		If, however there are other evidences, like identical answers in the answer-scripts, then the penalty shall be an FP grade.
8	Carrying unauthorized material during examination	If a mobile phone is found in the possession of a student during the examination, the penalty shall be FP grade in that subject or suspension for one or more semester.
		If a student is found carrying unauthorized material in theory examination (like chits, electronic gadgets like tablets, etc. (other than mobiles), using prohibited facilities like the internet etc., or is found with scribblings on one's body) the penalty shall be an FP grade in all theory subjects and/or suspension for one or more semester.
		If a student is found carrying unauthorized material in practical/ sessional examination (like chits, electronic gadgets like tablets, etc. (other than mobiles), using prohibited facilities like the internet etc., or is found with scribblings on one's body) the penalty shall be an FP grade in all practical subjects and/or suspension for one or more semester.
		Possession of such material with the student and report of the concerned faculty/invigilator is sufficient proof to attract the penalty.
9	Detection of copying during the evaluation of answer scripts	If during the evaluation of answer scripts of an exam, it is detected that a student A has copied from another student B, the disciplinary action taken against both students is an FP grade.
10	Making changes in valued answer script	If it is found that a student has made changes in valued answer scripts, the student shall be assigned an FP grade.

11	Communicating with others during toilet breaks during examinations	The disciplinary action taken against a student who is found using a mobile phone, chits, books and other unauthorized materials during toilet breaks, while the examination is in progress, shall be an FP grade and/ or suspension for one or more semester.
12	Repeat Offences	Repeat offences should be communicated to the Dean Academic. The disciplinary action taken against repeat offenders shall be suspension for one or more semester.
13	Plagiarism in Internal Reports: Reproducing material from sources like the web, texts, etc., without proper citations in seminar and project reports, etc.	Penalties for reproducing material in seminar reports without proper citation range from a warning (in case the mistake was unintentional) to loss of two grades in the Seminar. For project reports, the minimum penalty shall be loss of one grade and the maximum penalty shall be an FP grade.
		In more serious cases, like deliberately claiming false results on experiments, falsely claiming original content in a M.Tech. /M. Sc./Ph.D. thesis, the case should be referred to the Dean Academic and the minimum penalty shall be suspension for a period of one year and/or termination from the program.
		In exceptional cases, the matter is referred to the SSC/SUGB/SPGB/ Senate and the registration may be terminated, with or without an exit degree depending on the severity of the act. For the Ph.D. thesis, if the Dean Academic finds that the charges are proved, it may forward the matter to the Senate which may recommend withdrawal of the degree already awarded to the candidate.
14	Indiscipline by students serving as Teaching Assistant (TA) (normally M.Tech./Ph.D. students or Research Assistant/Associate, etc.)	If a TA is found aiding/abetting students in cheating by deliberately assigning inflated marks, tampering with the marksheet/ answer scripts etc., the disciplinary action shall be one of the following: (i) Discontinuation of stipend for one semester or entire remaining duration of the program. (ii) Suspension for one semester and/or discontinuation of stipend for the suspension period or entire remaining duration of the program.

ANNEXURE-I

What Constitutes Ragging?

Ragging constitutes one or more of any of the following acts:

- a) Any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
- b) Indulging in rowdy or indisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student.
- c) Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
- d) Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
- e) Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f) Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
- g) Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
- h) Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
- i) Any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher.
- j) Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of color, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.
