- (b) Pericyclic Reactions and Organic Photochemistry (SWAYAM/ NPTEL course, 08 weeks) course code CY24138.
- (c) The Department has assigned the mentor faculty for each course.
- (d) The evaluation process shall be done as follows:
 - (i) 50% weightage will be given to the marks they obtain in SWAYAM/ NPTEL exams, and 50% weightage will be for marks obtained in online/offline examination, to be conducted by the department.
 - (ii) Students shall be required to go through online/offline presentations for Major Project Part II.
