Item No.18.01: To confirm the Minutes of the Meeting of the 17th Senate held on 20th July 2021.

Item No.18.02: Action Taken Report.

Item No.18.03: To consider and approve the Implementation of Academic Bank of Credit (ABC) as per the National Education Policy 2020.

The Senate approved the implementation of Academic Bank of Credit (ABC) system at NIT Sikkim. The following committee was constituted to frame the detailed policy/ modality and requirements of the scheme and shall submit the above within one month:

Item No.18.04: To consider and approve the Multiple Entry and Exit Policy for various academic programs as per the National Education Policy 2020.

The Senate deliberated and approved in principle the implementation of Multiple Entry and Exit Policy for UG and PG programs under the edges of National Education Policy 2020.

The highlights of the policy are briefed as under:

- i) Students are allowed to leave the academic program at any point of time and can join again after a certain period of break.
- ii) The students are allowed to exit permanently from the program of study at any point of time with an academic award, if eligible.
- iii) There will be three exit points to B.Tech. students and one exit point in M.Tech./M.Sc. programs:

a) Exit policy for B.Tech. program:

Exit Level & Academic Award	Minimum Requirement	Nomenclature of Certification
Certificate	Successfully earned minimum 40% credits of the total credit of the program.	Certificate in (Name of Discipline/Branch)
Diploma	Successfully earned minimum 70% credits of the total credit of the program.	Certificate in (Name of Discipline/Branch)
Advanced Diploma	Successfully earned minimum 85% credits of the total credit of the program.	Certificate in (Name of Discipline/Branch)

b) Exit Policy for M.Tech./M. Sc. Program:

Exit Level & Academic Award	Minimum Requirement	Nomenclature of certification
Post Graduate Diploma	Successfully earned minimum 55% credits of the total credit of the program. The minimum stay at the Institute must be two semester.	Post Graduate Diploma in (Name of Discipline/Branch)

The senate raised the issue of the sanctity/equivalence of above certificates/degrees.

iv) Entry Points for all UG and PG Programs:

a) When there is no change in program structure:

Student's can take re-entry in the program if there are no changes in the curriculum (i.e. the curriculum of the programme is same as it was when student had its exit) and continue the course right from her/his exit point. The credits earned of exit level will be transferred to her/his academic Bank Credit. However, the DUGC shall assess the readiness of the students to continue with the program or may assign additional courses or part of course as a prerequisite before allowing her/him to continue with the regular program.

b) When program structure has undergone changes:

In case of the curriculum has been revised or updated, the DUGC shall ascertain the following and take the necessary decision to ensure successful completion of the program after re-entry:

- The student has to undergo the revised curriculum.
- The credit earned before the exit from the program will be evaluated and a decision regarding the actual credits to be considered towards the award of the degree will be taken.

- To bring the parity with the batch with which s/he will carry out her/his remaining studies (semesters), the DUGC will assess the readiness of the students to continue with the program s/he has left and if required may suggest additional courses or part of course before allowing her/him to continue with the regular program.

v) Implementation Schedule:

The Senate advised and approved the following points for implementation:

- The implementation of the policy will be made effective to the B.Tech., M.Tech. and M.Sc. programs for the students admitted in 2021 and onwards.
 - The issue of the equivalency and notification for recognition of various academic awards (Certificate, Diploma, Advanced Diploma, PG Diploma, etc.) will be raised in the next meeting of NIT council. The ministry may be requested for the necessary ordinances/statutory provision for effective implementation of the same.
- vi)** The following committee will prepare the detailed policy, ordinance, implementation modalities, etc. and the same will be placed in the next meeting for finalization. The committee shall submit the above within one month.
