Item No.32.09: To Consider and approve the action taken against the serious incident of indiscipline activity by the 3rd and 4th year B.Tech. students.

The Senate deliberated on the serious incident of indiscipline involving certain students of the 3rd and 4th year B.Tech. programs. The matter was discussed in the faculty meetings and also been thoroughly investigated by the Institute Disciplinary Committee. The faculty recommendations, action taken, Committee's findings and recommended disciplinary actions were presented before the Senate. After due discussion and consideration of all aspects, the Senate approved the disciplinary actions as recommended by the Institute Disciplinary Committee against the students found responsible for the act of indiscipline. The Senate also agreed with the faculty recommendations in this regard. The Senate also directed to give FP grade in the Behaviour and Discipline to the students who were actively involved in the aforementioned incident of writing abusive and derogatory statements and these students need to complete a 12-week course(s) relevant to Ethics and Moral Thinking to complete their degree through the Swayam Portal.

Item No.33.10: Any other items with the permission of the Chair.


