The Institute reserves the right to accept or reject any quotations or to select the item or to reject the bidding process or any quotation wholly or partly without assigning any reason. Incomplete bid or receiving the bid after closing date and time are liable to be ignored and rejected.

Instructions to Bidders

- 1. No expenditure other than quoted will be entertained. The total quoted price/amount must be in written in figures as well as in words. There should not be any overwriting, if there is any overwriting, the bid(s) shall be rejected. No alternate price will be entertained in the quotation.
- 2. All bid documents should have to be sent through courier, speed post or registered post only or may be dropped in the tender box at NIT Sikkim. Since, NIT Sikkim is located in a remote location, even though speed post it may take seven days. Therefore, bidders are suggested to send the quotation well in advance or by hand.
- 3. Quotation received after the closing date/time will not be considered. The quotations shall be submitted in a sealed envelope duly marked as "Tender for Microsoft OVS-ES" along with Tender/NIQ reference no and due on date.
- 4. In the event of any dispute or difference(s) between the vender/firm and Institute (NIT Sikkim) arising out of any reason, shall be referred to "The Director, NIT Sikkim", Sikkim whose decision shall be final and binding on the bidder(s)/firm.
- 5. All bids in which any of the prescribed conditions is not fulfilled or any condition is put forth by the bidder shall be summarily rejected.
- 6. Payment Clause: 100% payment will be released after successful online delivery of the e-licenses at NIT Sikkim.
- 7. Clarifications: In case the bidder requires any clarification regarding the tender documents, they may mail to icti@nitsikkim.ac.in.
- 8. **Pre– Qualification Criteria**:
 - a. The supplier/firm must be either original equipment manufacturer (OEM) or authorized dealer/sole distributor/channel partner. The bidders are essentially required to submit authorization certificate from the OEM (Microsoft), failing which the bid shall be rejected.
 - b. Bidders should be the manufacturer/authorized dealer.
 - c. An undertaking from the OEM is also essentially required stating that they will facilitate the bidder on a regular basis with technology/product updates/hardware support and any kind of support necessary to ensure smooth functioning and security requirements for the entire

duration of the contract period.

- 9. **Validity**: The bid should be valid for acceptance for a period of 30 Days. The Bidders should be ready to extend the validity, if required.
- 10. **Delivery**: The subscription must be delivered within 28 days.
- 11. **Liquidated Damage:** If the bidder fails to deliver the required services in the above mentioned period and the place, the penalty at the rate of 1% per week of the total order value subject to the maximum of 10% of total order value will be deducted.
- 12. In exceptional situation, an authorized committee may negotiate price with the qualified bidder quoting the lowest price before awarding the contract.
