Instructions to Bidders

1. The technical and financial bids should be quoted separately and put in different sealed envelopes marked as "Technical bid" and "Financial bid" which are to be put in separate envelopes and should be properly sealed. The EMD and Tender fee should be enclosed in the technical bid in the form of A/C payee DD in favours of "Director, NIT Sikkim".
2. All tender documents should have to be sent through courier, speed post or registered post only or may be dropped in the tender box at NIT Sikkim.
3. Quotation received after the closing date/time will not be considered.
4. While sending rates, the firm shall give an undertaking to the effect that "*the terms/conditions mentioned in the enquiry letter/Tender Notice against which the rates are being given are acceptable to the firm.*" In case the firms do not give this undertaking, their rates will not be considered.
5. The quantity shown against the item is tentative and may vary as per dynamic requirement of the Institute.
6. In the event of any dispute or difference(s) between the Institute (NIT Sikkim) and the vendor(s) arising out of non-supply of material or supplies not found according to specifications or any other cause whatsoever relating to the supply or purchase order before or after the supply has been executed, shall be referred to "The Director, NIT Sikkim", Sikkim who may decide the matter himself.
7. All tenders in which any of the prescribed conditions is not fulfilled or any condition is put forth by the tenderer shall be summarily rejected.
8. If the successful bidder fails to supply the goods within stipulated time, then the EMD may be forfeited and the purchase order will be cancelled.
9. Any bidder fails to supply the materials in full or partially within the stipulated time in the purchase order, the tender will be summarily rejected provided the amount of the supplied materials may be released on recommendation of the competent authority and penalty clause will be invoked.
10. The bidders may quote for single item or multiple.
11. The quoted price will remain valid for 3 month and no alteration/ change in rate is allowed after issue of Work Order/Purchase order.
12. You must submit the copy of (a) Firm registration certificate (b) Trade License; (c) GST registration along with your bid. All these certificates must be in construction trade.
13. Quotations may either be in (a) letter head or (b) format but duly stamped by the authorized signatory along with a forwarding letter on letter head. Otherwise the bid shall stand rejected.
14. Payment shall be made only after the receiving of materials against the Purchase Order with satisfactory level ensuring all the specification and the quality of the material/items ordered.
15. Contact Nos. and E-mail IDs of Authorized persons of the firm must be given.
16. NIT Sikkim can cancel fully or partially any one items all items based on their requirement or can increase or decrease the quantity. Bidder cannot claim any cost from NIT Sikkim.
17. The Contractor/Agency should not have been blacklisted by any central / state government bodies. Declaration of the same to be enclosed along with tender document EMD will be forfeited & tender will be rejected in suppression of the fact.
18. The price quoted should include transportation charges. The price quoted should be for NIT Sikkim, Ravangla. Please quote Taxes separately in the format as per existing rates.
19. The payment shall be released within 15 days of satisfactory delivery of the materials to the satisfaction of the institute committee.
20. Delivery period for all the items will be within 15 working days from the date of purchase order issued. The authority of NIT reserves the right to extend the delivery period on request with valid reason else following penalty clause shall be applicable.
21. Penalty Clause: a) 1% of the bill amount for delay in supplying of materials up to 15 days.
b) 2% of the bill amount for delay in supplying of materials up to one month.
c) 5% of the bill amount for delay in supplying of materials more than one month.

Date and time of opening of price bids will be decided after the committee has evaluated technical bids. In exceptional situation, an authorized committee may negotiate price with the qualified bidder quoting the lowest price before awarding the contract.

General Terms and conditions**Pre – Qualification Criteria:**

- Bidders should be the manufacturer / authorized dealer. Letter of Authorization from original equipment manufacturer (OEM) on the same and specific to the tender should be enclosed for items as required.
- ISO certified company shall be preferred.
- The bidder must be a registered/authorized firm with GST registration clearly mentioning the scope of items authorized to supply from the registration authority.
- The bidder must have experience in similar supply to central/state universities, IITs, NITs etc. in the past.
- Trade License should be valid for the financial year 2017-18.

Prices:

The Prices quoted should be inclusive of all taxes or duties, packing, forwarding, freight, insurance, delivery and commissioning etc. at destination site (NIT Sikkim, Ravangla, Sikkim). The rates shall be firm and final. Nothing extra shall be paid on any account. Taxes shall be applicable/deducted as per Central/state rule.

Delivery:

The materials should be delivered within the period as specified in the purchase order unless otherwise prescribed.

Specification

Any deviation in the material/item, and the specifications from the accepted terms may liable to be rejected and the bidders need to supply all the goods in the specified form to the satisfaction/ specifications specified in the order / contract.
