4. The institute reserves the right to not accept the lowest price as the sole criteria for award of the purchase order. The quality requirement of the institute shall not be compromised in any case. The institute may ask any bidder to submit the sample of the material before award of the order.

NIT Sikkim being a Public Funded Research Institution vide Notification No. 45/2017 - Central Tax (Rate) and No 47/2017 - Integrated Tax (Rate) is eligible for concessional rate of GST on purchase of multimeter.
