Other Terms and Conditions are as under:

1. The quotation shall be in the letterhead of the bidder and must contain the GST& PAN of the bidder. The quotation shall be addressed to the Registrar NIT Sikkim. Physical sealed quotations shall only be accepted. Email quotations shall not be considered for evaluation.
2. The prices quoted should be FOR NIT Sikkim and must include all incidental charges for services at NIT Sikkim. Taxes if any should be clearly indicated in the quotation. The rates of taxes should be clearly spelt out in the quotation.
3. The Work must be completed within 15 days of the issue of the Work Order or as per the direction of the engineer incharge. Failure to comply with the same shall result in liquidated damages recovered @ 1% per week.
4. The institute reserves the right to not accept the lowest price as the sole criteria for award of the purchase order. The quality requirement of the institute shall not be compromised in any case. The institute may ask any bidder to perform sample work before award of the order or visit the site for clarification.
5. The institute reserves the right to increase or decrease the quantity of the work depending on the need of the institute.
6. The lodging and fooding for the manpower deployed for installation and works shall be sole responsibility of the contractor. No fooding and accommodation shall be provided by the Institute.
7. Submission of quotation shall be deemed to be the acceptance of the conditions in this document.
8. Only regular registered vendors are eligible to bid and the GST registration certificate of the bidder must be submitted with the bid.
