Notice Inviting Quotations

The National Institute of Technology Sikkim invites quotations in sealed envelopes for disposal of Felled logs at Dung Dung Khamdong East Sikkim as firewood and timber to be submitted to the Executive Engineer, NIT Sikkim. The last date for submission of the quotation is 25.02.2025, 3: 00PM.

Disposal Details

Item Brief : Auction of felled logs at Dung Dung Khamdong East Sikkim as firewood and timber on as is where is basis.

Location Details : The permanent campus of NIT Sikkim is being developed at Dung Dung Khamdong Gangtok District Sikkim and trees and poles have been felled at the site with the approval of the Forest Department, Govt of Sikkim. The felled logs have been stacked and are to be auctioned to the H1 bidder. The logs have been classified as Firewood logs and mixed timber as per the applicable rules and regulations of the Government of Sikkim.

Details of Trees and Logs to be disposed:

The Sikkim Government Gazette No 249 dated 13 Oct 2020 is the guiding document for valuation and regulation of rates and quantity.



Terms and Conditions are as under:

1. The H1 quotation submitted on or before the due date shall be declared the successful bidder for the sale of the said trees and the H1 bidder shall be invited for the disposal process.
2. The H1 bidder shall have to deposit an security deposit of Rs 10,000/- immediately after the LoI is issued. The same shall be adjusted against the amount to be deposited for the disposal of the trees to the Institute.
3. The reserve price for the trees in mentioned in schedule "A". Prices below the reserve price shall be summarily rejected.
4. The trees are to be removed from the site immediately by the successful bidder and the same must be done within 15 days of the LoI/LoA.
5. No charges shall be paid by the auctioneer on any account such as transportation/government fees/felling charges/sawing charges etc.
6. All responsibility of transportation etc shall be of the successful bidder.
7. The Institute has prior permission for felling and auction of the trees from the Forest Department Govt of Sikkim and all charges and fees for the same have been paid by NIT Sikkim.
8. GST and TDS shall be applicable as per the rules.
9. The bidder must enclose the PAN and GST registration as applicable along with the bid quotation.
