2. Total amount of Institute fee and hostel fee for 1st semester 2021-22 is **Rs.96,950/**_(Rupees Ninety Six Thousand Nine Hundred Fifty only) for General and OBC Candidate and **Rs.34,450/**_(Rupees Thirty Four Thousand Four Hundred Fifty only) respectively for SC/ST & PwD candidates. *However, the tuition fee waiver is available for Socially & Economically Backward Students belonging to the General and OBC category* (For more fee details please refer **Sl. No. 5 & 6**).

The remaining amount, after payment of Seat Acceptance Fee and Partial Admission Fee in JoSAA and CSAB portal shall be payable to the Institute at the time of online reporting and provisional admission.

3. Regarding hostel accommodation:

- (a) All the students will be provided hostel accommodation. Only local students may be permitted as Day Scholars subject to application by parent and approved by the competent authority of NIT Sikkim.
- (b) Accommodation will be provided on sharing basis depending on the size of the rooms.

4. Regarding Mess & Bus Facility:

Boys & Girls Mess: The boys & Girls mess is run by a mess contractor authorised by the Institute. Resident students must have to avail the food at the Institute run mess. The mess fees per semester (approx.) is Rs. 20,000/- (Rupees Eighteen thousand only).

Institute Bus: The Boy Hostels are located at Ravangla Bazar which is 2 KM away from the campus. To avail the bus facility an amount of Rs. 1500/- per semester will be charged separately.
