INSTRUCTIONS FOR ONLINE ADMISSION (PROVISIONAL) TO M.TECH. PROGRAMMES THROUGH CCMT-2020 FOR THE SESSION 2020-22

[ALL THE CANDIDATES ARE REQUESTED TO CAREFULLY READ THE INSTRUCTIONS]

For the admission to M.Tech. Programmes at National Institute of Technology Sikkim through CCMT-2020, all the candidates who are allotted NIT Sikkim are advised to follow the following admission procedures,

1. Fill the **Google Form** which has already been sent in the candidate's email id on **19th September 2020**. The last date of filling up the form is **25th September 2020**.
2. Merge the **scan copy** of all the original documents as per the sequence given in **Annexure-I** and **e-mail** the merged file of all documents to **pg.admissions@nitsikkim.ac.in** on or before **29th September 2020**. The subject of the email should be "**Admission to M.Tech Programme through CCMT-2020**"
3. Self- attested copies of one set of all the documents along with affidavits (original) has to be sent in the following address through Speed Post,

The envelope should be superscribed with "Admission to M.Tech Programme through CCMT-2020" and it should reach on or before **25th October 2020**.

4. **Hard copy of all the documents has to be produced during physical reporting. The date of physical reporting will be intimated later**

Important Instruction

Upon submitting the documents, it will be scrutinized and **provisional admission** will be given, subject to submission of original documents on reporting to NIT Sikkim campus physically. If certificates are found to be **in-genuine**, the admission will be **cancelled and all fees paid will be forfeited**. Due to Covid19 pandemic, there is no need of physical reporting at this moment to NIT Sikkim. However, classes will start ONLINE from **1st October, 2020**. The date of physical reporting will be intimated later.

14. Family Annual Income Proof (Last three-month Salary slip if parents are government employee & latest Income certificate for others) and Affidavit declaration (In prescribed format- **Annexure-III**) (**only for SC/ST**)*.
15. Medical Certificates (Format attached at **Annexure-IV**)
16. Affidavit (**Annexure-V**)

Note:

- Students who are not having Migration/Conduct/ Transfer Certificate are required to submit the undertaking form as given in **Annexure-VI** for submitting the certificates latest by 30th October 2020.
- After the last withdrawal/cancellation date of CCMT 2020, if an admitted student cancels admission/ withdraws/leaves the Institute without completing the entire programme, all fees paid will be forfeited by the Institute.
- *For SC/ST candidate whose family income is less than 4.5 lakhs as per the annual family income are exempted from tuition fee. In case the SC/ST candidate who unable to produce annual family income proof along with affidavit declaration at the time of admission are liable to pay the full tuition fee. If any candidate unable to produce the above-mentioned documents, may claim fee remission on production of documents before 01st November 2020.
