**Applicable for B.Tech. (4<sup>th</sup>, 6<sup>th</sup> & 8<sup>th</sup> Sem)., M.Tech., M.Sc., & Ph.D ONLY**

The semester registration dates and basic guidelines for even semester 2020-21 are as follows:

1. **The** semester registration fees for Even semester 2020-21 are published in the Institute website.
2. **The** payment is accepted through online mode, preferably SBI payment gateway and the link is available in the institute website. ([www.nitsikkim.ac.in](http://www.nitsikkim.ac.in) >Admission >Fee Structure > Online payment gateway.....SBI> ) You are required to select 'All India' as State of Corporate/Institutions.
3. **The** students may also use credit/debit card or other online instrument for the payment of fee. However, the online transaction details have to be uploaded in the registration form.

4. **The** students have to deposit fees from **5<sup>th</sup> January to 16<sup>th</sup> January 2021.** Other modes of payment such as demand draft, banker's cheque are **NOT** accepted.
5. Once the payments of requisite fees are complete, the students have to fill up the online registration form. **The link of the google registration form will be sent in the students e-mail.** In case of any difficulty, students are advised to contact Faculty Advisor's of the concerned department.
6. The registration process begins from **11<sup>th</sup> January and completed by 16<sup>th</sup> January 2021.** The students need to submit the online registration form along and upload of fee receipt within the stipulated date of registration. Non submission of form within the above registration period shall be treated as **Not- registered for the Even semester 2020-21.**
7. Online **Classes commences form 18<sup>th</sup> January 2021.**

**Fee Remission for Even semester 2020-21 (For B.Tech. only):**

The tuition fee remission is based on the annual family income for socially and economically weaker students as per the MHRD notification and submission of family annual proof along with joint affidavit declaring the family income for

academic year 2020-21. The Institute has reviewed and finalised the list of students and their category of tuition fee exempted/waiver and remission and communicated to the students through mail. Students are advised to pay the registration fee accordingly.
